

Rental Equipment Agreement

Bike hire

Bikes and Equipment Rental Agreement between Taymouth Marina, Kenmore, Perthshire PH15 2HW herein called, "Lessor," and the undersigned, herein called, "Renter."

This agreement constitutes a Waiver and Release of Liability, whereby the Renter agrees to release, discharge, hold harmless, defend and indemnify Taymouth Marina and its owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful, loss of services or otherwise which may arise out of Renter's use of Equipment, premises or facilities or Renter's participation in activities.

By signing this document, Renter acknowledges he/she specifically understands he/she (Renter) is releasing, discharging and waiving any claims or actions that they may have at the present time, or in the future, for the negligent acts, omissions or other conduct by the owners, agents, officers or employees of Taymouth Marina.

Renter must bring proof of identification, must be provided upon collection of your equipment and must include a photo ID e.g. Driving license or passport.

Renter will only use bicycles on appropriate roads, cycle paths and trails.

Renter must be a competent rider.

Renters will not undertake any manoeuvres which are beyond their level of skill or beyond the design purposes of the equipment.

Renter will return the bicycles in the same condition they received them from Taymouth Marina.

Renter accepts that cycle helmets must be worn at all times whilst using the bicycle.

Renter shall bear all risk and responsibility for themselves & any other damage, loss or theft of the rental equipment, or any portions thereof (including, but not limited to vandalism) and shall pay the Lessor the full cost of repair or replacement.

Renter understands that refunds cannot be given for punctured tyres or damage to gears as a result of incorrect use.

Taymouth Marina can refuse to rent out the equipment to any person or terminate use of the Equipment by any person whom they believe is either unwilling or unable to use the equipment appropriately and competently. The renter accepts the lessor's right to take such actions for the safety of the renter and other persons.

I understand that components such as brakes, tyres and control cables will deteriorate whilst riding and accept this inherent danger.

I confirm that I know and will fully abide by UK traffic laws.

I have read, understood, and hereby accept the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon myself, my heirs, successors, assigns, and for all family members, including any minors accompanying me.
